#### Water Quality Report 2/18/2019:



The water in Kitching Cove is tested weekly and results are sent to the Florida Oceanographic Society where they are integrated into a large database monitoring the St. Lucie River and Indian River Lagoon.

These results are published every Saturday in the local newspaper. Without Lake Okeechobee discharges the water has been very good supporting mullet activity, jellyfish and even some dolphins. The pelicans have been very busy feasting on surface fish.

There has been significant reorganization of the South Florida

Water Management District and a strong movement to change the Army Corps of Engineers operating schedule of the lake. Many factors determine if the discharges must occur so these new events may decrease the threat of these devastating discharges. Stay tuned for upcoming news. Dave Carlson

# Tips for Rust Stain Removal:

This is a real nuisance in our community with respect to irrigation wells. There is some truth to the fact that the deeper the well, the less iron and more sulfur (rotten egg smell).

So as a homeowner you can do the following:

-Purchase a product called IRON OUT that will remove these stains. This product should be used with care. Read the precautions and understand them. Spray the product, wait a few seconds and rinse. It works well for mailboxes and small stains on the house.

For larger areas you may need to use a garden sprayer.

-Consult with your irrigation specialist for ideas that may work.
